\*\* The above tree companies have been approved by the City of Nampa Forestry Department to perform work (pruning, removal, etc.) on trees located in the public rights of way. To be licensed by the City of Nampa, each of these companies must employ at least one individual currently certified as an arborist by the International Society of Arboriculture (ISA). ISA Certified Arborists have extensive training and have completed an intense exam relating to safety, the growth, proper pruning techniques and healthy maintenance of trees. Proof of adequate insurance (minimum \$500,000) against property damage is required prior to licensing. The City of Nampa, Forestry Department, feels these requirements will help protect the trees, the arborists, and the property owner.
